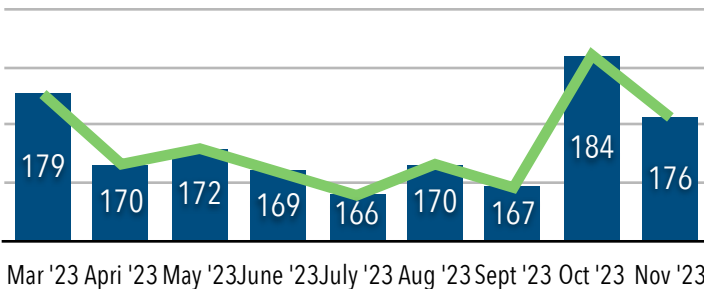


# DECEMBER 2023 REVIEW

Monthly Clients Served 9 Month Trend

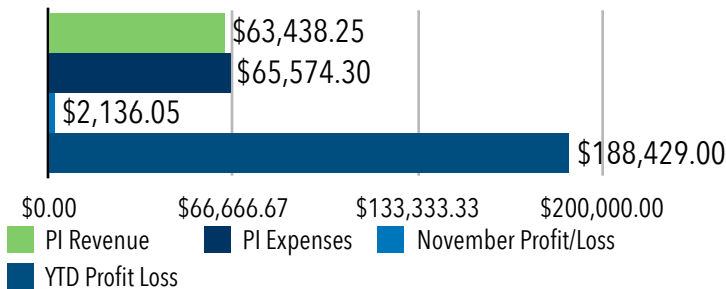

**WORK RELEASE UPDATES:**

There currently are 28 work release residents: 22 males and 6 females, an 8% increase from last month. Community Corrections continues to collaborate with Court Services to increase residential therapeutic services doubling the amount of peer hours and increasing classes.

**NOVEMBER OVERVIEW:**

Community Corrections served a total of 176 clients in November, a 4% decrease: 39 via the Work Release Program and 122 via the Home Detention/Electronic

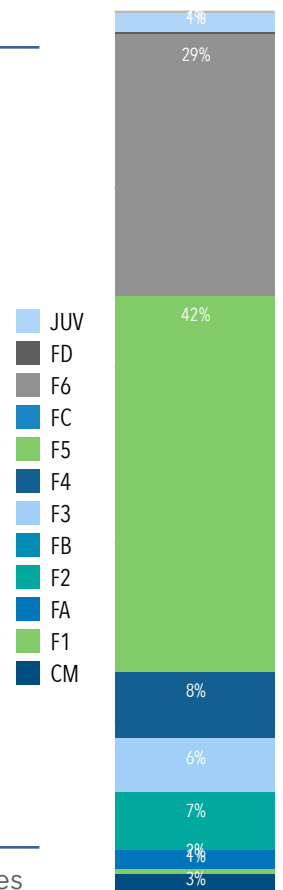
Monitoring Program for a total of 4,378 days supervised. It is noted that 17 clients have been transferred to other jurisdictions for supervision. The average daily Work Release Population was 36, while the average for Home Detention was 109.

The department received 15 new clients in November:

- 6 Level 6 Felonies
- 8 High Level Felonies (Lvl 5 & Above)
- 0 Criminal Misdemeanors
- 1 Juvenile GPS Supervision

20 clients successfully completed the program, while 3 clients were returned to either the Cass or Pulaski County Jail on a pending violation, with 9 held in the CCJ on pending violations.

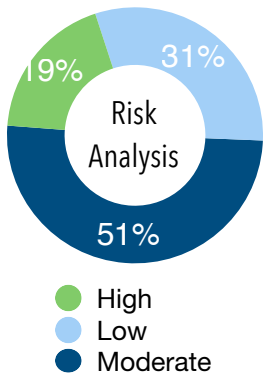

**POPULATION ANALYSIS:**

- 39 Work Release Clients
- 122 Home Detention Clients
- Approximately 15 Clients participated in Work Crew; working on projects including watering, trash removal & helping with other miscellaneous projects
- 2 CTP Clients
- 24 Courtesy Transfers
- 133 clients were serving a term originating from Cass County, while 30 were serving a sentence from Pulaski County

-3 clients participated in Juvenile GPS Monitoring



**RISK & OFFENSE TYPE ANALYSIS:**

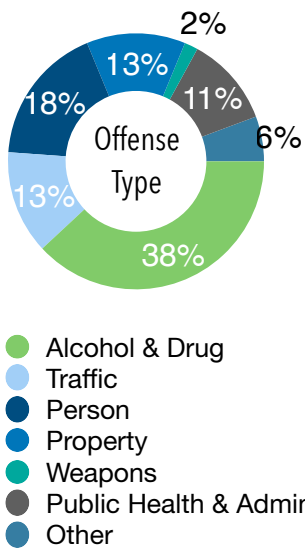
Risk Analysis: Analysis shows that 19% of clients served in November were identified through the IRAS Community Supervision Tool or IYAS as High Risk to Very High Risk, 51% as Moderate Risk, and 31% as Low Risk, with an average risk reduction of -19.5%.

Offense Type Analysis:

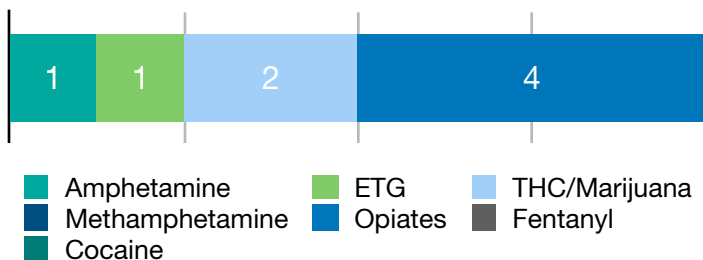
Analysis shows that 38% of offenses are drug and alcohol related, 13% are traffic offenses, 18% are crimes against persons, 13% property related, 2% weapon related, 11% public health and admin., and 6% fall into the other category.

**DRUG SCREEN ANALYSIS:**

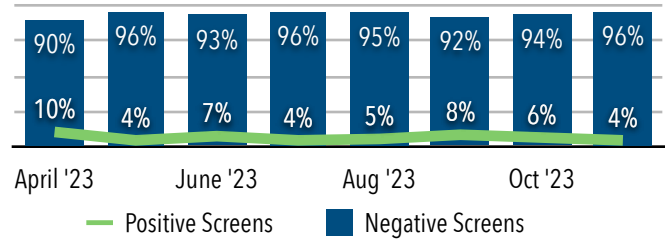
Out of 162 drugs screens administered this month, 4%, were positive, a 2% decrease. The majority of positive screens were for THC & opiates.



**Positive Screens by Drug**

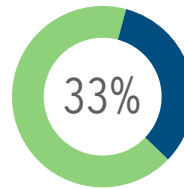


**Percent Positive Screens 8 Month Trend**

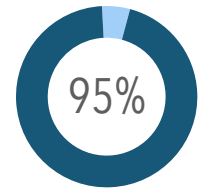


**PERFORMANCE METRICS:**

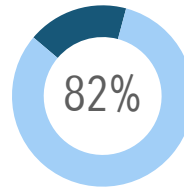
At the direction of our local JRAC, the agency is now tracking the following performance metrics.



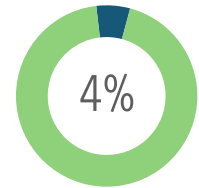
**Violation Rate:** the percentage of clients who received a violation; pending violations are NOT included; this is a measure of closed cases.



**Safety Rate:** the percentage of clients who do not commit a new offense while under supervision; this is a measure of closed cases.



**Completion Rate:** the percentage of clients who remain under supervision until the end of their sentence.



**Drug Screen Positivity Rate:** the percentage of drug screens administered that return a positive result

**NOTABLE UPDATES:**

- CPCC is partnering with Court Services to bring in Justice Systems Partners and NIC to facilitate a multi-agency wide EBP training.
- With Court Services, the agency entered into an MOU with 4C Health increasing peer hours by 50% at both community corrections and pretrial services. Work is underway to bring in additional facilitators for Saturday Programming and new curriculum from the Change Company has been implemented.
