OCTOBER 2024 REVIEW | CASS COUNTY COURT & PRETRIAL SERVICES

"Serving the community by using evidencebased practices and <u>needs-based supervision</u> that prioritizes public safety, maximizes court appearance and reduces recidivism, while protecting the presumption of innocence."

CURRENT OVERVIEW:

In September, Pretrial Services served a total of 156 clients, representing a 26% increase from September 2023. These clients accounted for 3,878 days or 10.6 years of jail bed stays. The program currently has 119 active clients, with an September average daily population of 129. To date, Pretrial Services has surpassed the 2023 population served, serving 310 clients thus far. The majority of the current caseload, 80%, involves felony charges. Additionally, the program completed 35 arrestee evaluations and recommendations, including IRAS-PAT assessments, in the last month. There were also 26 new clients added to the program in September.

Currently, we have an 89% Release Rate. 18 clients successfully completed the program. 25 clients are participating in voluntary individual counseling with our 4C Health Therapeutic Intern. We currently have 9 clients in inpatient treatment. We have secured 73 clients voluntary beds and admissions into inpatient treatment with an 87% Completion Rate.

JAIL ANALYSIS:

The September Jail Analysis showed that 15% of inmates are classified as Pre-Adjudication with 52% having a hold that excludes them from pretrial release. The Cass County Jail population is 181 inmates, an 9% increase: 120 Cass County, 7 Carroll County, 33 Howard County, 21 IDOC. Currently, with expansion, the jail is at 59% capacity. It is estimated that without Pretrial Services the jail would be at 98% capacity The low risk population is currently 10%, a 25% decrease from January, while the high risk population continues to rise, with 44% of the population, identified as high risk, illustrating the


reservation of jail resources for high risk inmates and maximized risk-based release decisions.

COST SAVINGS:

Utilizing the \$40 daily per diem, CCCPS has diverted an estimated \$4,760 per day in incarceration expenses, resulting in a reported cost savings of \$155,120 for September. Due to this reservation of jail resources, the CCJ can now house inmates from other facilities, generating an additional \$34,160 in revenue in September from 40 inmates housed for a total of 854 days. Approximately 34% of the jail population is eligible to produce billable revenue.


Monthly Clients Served 13 Month Trend Analysis

RISK & OFFENSE TYPE ANALYSIS:

Risk Analysis:

Trends show that 9% of active clients have been identified through the IRAS-PAT as High Risk, 55% as Moderate Risk, and 35% as Low Risk.

Offense Type Analysis:


Analysis shows that 37% of offenses are drug and alcohol related, 26% are traffic offenses, 14% are crimes against persons, 7% property related, 1% weapon related, 6% public health and admin., and 9% fall into the other category.

Supervision Analysis:

-37% of active participants are being supervised at Level 3

(High) Supervision, with weekly reporting.

- 20% of active clients have needs where supervised release was in the best interest of the county and the clients.
- 0 clients are being supervised with electronic monitoring facilitated by Cass/Pulaski Community






PERFORMANCE METRICS:

- We are happy to announce receipt of \$175k in new funding this past month via various grants awarded.
